Ambiq Micro, Inc. (Ambiq) hereby certifies that based on the information provided by our suppliers, and to the best of our knowledge, our products are in compliance with the "DIRECTIVE 2011/65/EU OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 8 June 11" (2011/65/EU RoHS recast) and the amending Annex II by (EU) 2015/863 on the restriction of the use of certain hazardous substances in electrical and electronic equipment.

RoHS 2011/65/EU Directive Compliance (with Amending Annex II by EU 2015/863)

The directive restricts the use of ten substances within electrical and electronic equipment. The substances and their allowed concentrations are listed in the following table:

| Cadmium and its compounds | 100 ppm (0.01 weight %) |
| Mercury and its compounds | 1000 ppm (0.1 weight %) |
| Hexavalent chromium and its compounds | 1000 ppm (0.1 weight %) |
| Lead and its compounds | 1000 ppm (0.1 weight %) |
| Polybrominated biphenyls (PBB) | 1000 ppm (0.1 weight %) |
| Polybrominated diphenyl ethers (PBDE) | 1000 ppm (0.1 weight %) |
| Bis (2-ethylhexyl) phthalate (DEHP) | 1000 ppm (0.1 weight %) |
| Butyl benzyl phthalate (BBP) | 1000 ppm (0.1 weight %) |
| Dibutyl phthalate (DBP) | 1000 ppm (0.1 weight %) |
| Diisobutyl phthalate (DIBP) | 1000 ppm (0.1 weight %) |

Important Notes:

- 1. In determining the RoHS status of its products, Ambiq relies upon its suppliers' material content data certification for each homogeneous material in the product(s) that they or their subcontractors provide. The signature below verifies that statements above, including but not limited to material composition data are valid and accurate to the best of our knowledge for Ambiq products in original sale condition.
- 2. For these purposes, RoHS compliant means that:
 - Our supplier has confirmed the compliance status of the relevant products to us.
 - We have implemented processes to confirm suppliers' statements and maintain relevant documents to support this.
- 3. To the best of our knowledge, none of our suppliers use these banned substances to manufacture our products. Our statements in this document regarding RoHS compliance and lead content do not extend to, or apply to any product subjected to unintended contamination, misuse, neglect, accident, or improper installation.
